Turn your Ohio tax credit into scholarship monies for a student with a dollar for dollar tax credit!

Sts. Peter & Paul School has partnered with *Every Child Every Family* and *The Diocese of Toledo*, They are both Scholarship Granting Organizations (SGO).

If you have a tax liability with the state of Ohio and you make a donation to this SGO, then you can receive a 100% tax credit for your donation. Individual donors can receive up to a \$750 tax credit on their state tax liability (individual) or \$1,500 (married filing jointly). *Be certain to select Sts. Peter & Paul School (Ottawa) through the SGO.*

As a supporter of Catholic education, this gives you the choice to designate funds toward a child's education rather than to the state of Ohio.

<p>Review your state of Ohio tax liability. If you have a tax liability, individual donors can receive up to a \$750 tax credit on their state tax liability (individual) or \$1,500 (married filing jointly).</p> <p>If your taxable income is \$44,250/yr or more, you likely qualify for the \$750 in tax liability.
